INSTRUCTIONS

1. Call the Court to reserve an ex parte hearing date.
2. Fill out page 2 of this form to make your request to the Court; fill out the top of page 3, then fill out the forms you want the Court to file (i.e. summons or default).
3. By 10 a.m. the court day (not calendar day) BEFORE your hearing, you must notify the other party to let them know what you are asking the Court to do and why. Complete a Proof of Service which describes how you gave notice. Visit <https://www.courts.ca.gov/> for Judicial Council forms.
4. By 2 p.m. the court day (not calendar day) BEFORE your hearing, you must file your documents with the Court.
5. Attorneys must file the ex parte documents electronically. Please select an E-File service provider of your choice, many of whom are listed on the Court's website at this link: <http://www.odysseyfileca.com/service-providers.htm>.
6. Self-represented parties can file documents electronically or place them in one of the drop boxes located at the Monterey and Palm Street entrances, at the San Luis Obispo County Courthouse in San Luis Obispo. The drop boxes at both the Paso Robles and Grover Beach branches are unavailable for filing until further notice.
