Q: May I still attend court if my youth is detained and his/her/their case is being heard?

A: The Court strongly DISCOURAGES personal attendance by anyone at the courthouse for any juvenile court hearing due to the severe health threat posed by the pandemic and the transmission of the virus based upon personal contact. Instead, attendance is welcomed and encouraged through telephonic and/or video appearance. In exceptional circumstances the court will entertain an application made in advance to attend a hearing. Note, however, that the youth typically will not be present in the courtroom but will also be appearing through remote technology.

Appearances in Juvenile court are made electronically. Please contact your attorney, social worker or probation department for specific information on appearing by Zoom for your hearing.
