INSTRUCTIONS TO VACATE CIVIL ASSESSMENT

What is a Civil Assessment?

A Civil Assessment of \$300.00 is imposed against anyone who fails to pay a court ordered fine or fails to comply with any other court-ordered obligation by the due date. This Civil Assessment is imposed in addition to any fine connected with your case.

Can I have the Civil Assessment vacated?

You may ask the Court to vacate the Civil Assessment *if* your failure to comply was caused by one of the following:

- 1) Hospitalization
- 2) Incarceration
- 3) Active military duty
- 4) Death of an immediate family member

How do I vacate the Civil Assessment?

In order to request that the Civil Assessment be vacated, you must:

- 1) Fill out the attached Petition
- 2) Provide written documentation of the reason for your failure to pay.

Examples of written documentation are: records of admission and discharge from the hospital; court orders to remand into custody/or records of release from custody; appropriate military orders for active service; or death certificate and documentation of relationship to the deceased.

What happens after the Petition is filed?

Your Petition will be reviewed promptly for a decision. Once the Court has reviewed the Petition and supporting documentation, a decision will be made to either grant or deny your Petition.

You will be notified of the Court's decision by mail. It is important that you supply the Court with your correct address to ensure you receive the Court's ruling on your Petition to Vacate Civil Assessment.
