1. Introduction

The San Luis Obispo Superior Court has approved the 2025 Bail Schedule pursuant to Penal Code section 1269b effective October 10, 2025. It is available online at slo.courts.ca.gov/forms-filing/fee-bail-schedules.

The Bail Schedule sets the presumptive bail amount, applicable throughout San Luis Obispo County to all arrests without a warrant for offenses that allow bail until the matter is reviewed by a judge.

Once the person is brought before a judge for arraignment, the judicial officer has the discretion to lower or raise the bail based on the actual charges filed, including any enhancements and prior convictions alleged. In doing so, the judicial officer considers the factors set forth in Penal Code section 1275(a), such as the protection of the public and victim, the seriousness of the offense charged, the person's previous criminal record, and the probability that they will appear at future court hearings. The safety of the public is the primary consideration.

The judicial officer also shall consider the person's ability to afford bail, and other individualized factors that bear upon the risk to the safety of the public and the victim, as well as the person's likelihood of appearing at future hearings. The judicial officer will consider whether less restrictive, non-financial conditions of release are appropriate in accordance with *In re Humphrey* (2021) 11 Cal.5th 135.

Persons charged with the following offenses are not entitled to be released on bail:

- a. Capital crimes (i.e., murder with special circumstances), when the facts are evident or the presumption great (California Constitution, article I, section 12(a); Penal Code §1270.5);
- b. Felony offenses involving acts of violence on another person when the facts are evident or the presumption great and the Court finds based upon clear and convincing evidence that there is a substantial likelihood the person's release would result in great bodily harm to others (California Constitution, article I, section 12(b)); and
- c. Felony offenses when the facts are evident or the presumption great and the Court finds based upon clear and convincing evidence that the person has threatened another with great bodily harm and that there is a substantial likelihood that the person would carry out the threat if released. (California Constitution, Article I, section 12(c).)

2. Prohibition Against Release on Bail in an Amount Other than the Bail Schedule Amount – Violent and Serious Felonies and Enumerated Felonies

Penal Code section 1270.1 prohibits the release of a person on bail in an amount other than that set forth in the Bail Schedule prior to hearing in open court for:

- (1) Violent felonies as described in Penal Code section 667.5(c), but not section 460(a) [residential burglary];
- (2) Serious felonies as described in Penal Code section 1192.7(c);
- (3) Violations of Penal Code sections 136.1(c), 243(e)(1), 262, 273.5, 273.6, 422 (as a felony), and 646.9.

The violent felonies and serious felonies are identified in the Bail Schedule.

3. Prohibition Against Release Prior to Judicial Review – Health & Safety Code section 11395 and Penal Code section 666.1

A person arrested for a violation of Health & Safety Code section 11395 or Penal Code section 666.1 cannot be released prior to judicial review to make an individualized determination of risk to public safety and likelihood to return to court.

4. Holds for Out-of-County Charges

The Bail Schedule applies to holds placed for out-of-county charges when no amount has been established previously or shown on a warrant.

5. Requests for Bail Increase (Penal Code §1269c) or Hold (Penal Code §1275.1)

Prevailing legislation places the burden on law enforcement agencies to notify the magistrate if the scheduled bail is not adequate for the crime (Penal Code § 1269c); or if there is probable cause to believe the source of funds for bail was feloniously obtained (Penal Code § 1275.1). The law enforcement officer shall follow the instructions below:

- a. Prepare a “Declaration In Support Of Motion To Increase Bail Above Schedule” or “Examination of Source of Bail,” setting forth the facts and circumstances in support of the belief that the presumptive bail is insufficient or the source of the bail should be examined;

- b. Submit the form for consideration to the on-call judge by contacting the Court's on-call answering service. The judge will review the request and if granted will sign the order and send it back to the requesting officer. The law enforcement officer will provide the signed order to SLO Custody Records to effect the bail increase.

Note: "If, after the application is made, no order changing the amount of bail is issued within eight hours after booking, the defendant shall be entitled to be released on posting the amount of bail set forth in the applicable bail schedule." (Penal Code § 1269c.)

In the event a declaration challenging the source of bail is filed with a judge, if the declaration "is not acted on within 24 hours, the defendant shall be released from custody upon posting of the amount of bail set." (Penal Code § 1275.1(g).)

6. Bail for Unlisted Felony Offenses

If no presumptive bail is specified, the pre-arraignment presumptive bail for felonies shall be \$20,000, up to the time of arraignment, UNLESS any enhancement or special allegation is alleged. If any enhancement or special allegation is alleged, presumptive bail shall be set pursuant to the schedule for the enhancement or special allegation and the underlying offense.

7. Bail for Unlisted Misdemeanor Offenses

If no presumptive bail is specified, the pre-arraignment presumptive bail for misdemeanors shall be \$0, up to the time of arraignment.

8. Bail Exceptions for Misdemeanor Offenses

- a. General Exception for Existing Out on Bail, OR, PAMP, or Warrants. If the person is out on bail, own recognizance, Post Release Monitoring Program (PAMP), or has one or more outstanding warrants on pending cases, and is subsequently arrested on a new misdemeanor, the presumptive bail on the new misdemeanor is \$10,000 (even if the new offense is an otherwise \$0 bail qualifying offense) or the scheduled bail amount, whichever is higher.
- b. Specific Exception for Persons with Three or More DUI Cases Pending. If the person is out on bail, own recognizance, Post Release Monitoring Program (PAMP), or has outstanding warrants on three or more cases involving pending DUI charges or pending DUI probation violations and is arrested on a new DUI charge, the presumptive bail on the new DUI case is \$25,000.

9. Bail for Multiple Offenses

The presumptive bail for a case with multiple charges shall be established as follows:

- a. When a person is booked on, or charged with, two or more offenses arising from the same course of conduct on the same occasion and against the same victim, bail shall be the amount set for the charge having the highest presumptive bail, including any enhancements.
- b. When a person is booked on, or charged with, two or more offenses committed against separate victims, the presumptive bail for each offense shall be added together and stacked. Amounts for enhancements and prior convictions shall be added one time per defendant or case.
- c. When a person is booked on, or charged with, two or more offenses committed on separate dates, the presumptive bail for each offense shall be added together and stacked. Amounts for enhancements and prior convictions shall be added one time per defendant or case.

10. Bail for Enhancements and Prior Convictions

Bail for enhancements and prior convictions listed in the bail schedule shall be added to the base bail for the listed crime.

11. Bail for Violations of Probation, Mandatory Supervision, Post Release Community Supervision, and Parole

- a. Presumptive bail on an arrest without a warrant shall be No Bail if the charge is for a violation of felony probation, mandatory supervision, post release community supervision, or parole.
- b. Presumptive bail shall be \$15,000 if the charge is for a violation of misdemeanor probation.

12. Felony Bail Schedule

Presumptive bail for unlisted felony offenses is \$20,000. See section 11 above if the person has been released on bail, own recognizance, or Post Release Monitoring Program.
