The Superior Court of San Luis Obispo County will be offering a training session for Bench Conduct and Demeanor, as identified in California Rule of Court 2.813(a), for court appointed temporary judges, and qualified attorneys interested in serving as temporary judges. This training qualifies for three (3) hours MCLE participatory credit and one (1) hour MCLE Elimination of Bias specialty credit.

Pursuant to California Rule of Court 2.812, to serve as a court appointed temporary judge an attorney must meet the following experience and conditions:

- Admitted to practice as member of the State Bar of California for at least 10 years before the appointment;
- In good standing with the State Bar, and no disciplinary actions pending;
- Has not pled guilty or no contest to a felony, or has not been convicted of a felony that has not been reversed; and
- Has satisfied all education and training requirements per Rule 2.812(c).

Training required pursuant to California Rule of Court 2.812(c) before serving as temporary judges includes:

- Bench conduct and demeanor (live/in-person training);
- Ethics; and
- Substantive training in specific bench assignment (e.g. small claims, traffic).
