- Do not harm or threaten to harm yourself, others, or others’ property.
- Do not commit criminal law violations.
- Do not possess any firearms or illegal weapons.

- Agree to be supervised by the Probation Department and comply with their directives.
- Submit to the search of your person and property without probable cause by the Probation Department or Law Enforcement Officer.

- Submit to random drug and alcohol testing when directed by the Probation Officer.
Submit to the use of a BacTrack Alcohol testing device provided by Probation.
- Be placed on electronic monitoring device provided by the Probation Department.
- Sign all releases of information, as required, to monitor compliance with the terms listed in this Conditions of Release.
